## Still More Helmet Use – Worldwide

Helmet usage among skiers and riders in the U.S. rose 12 percent to 48 percent of all skiers according to a recent study. Other data includes: 77 percent of children 9 and under, 66 percent of kids between 10 and 14, and 63 percent of adults over 65 all wear helmets. In comparison, only 25 percent of skiers and snowboarders wore helmets in the 2002/03 season. The annual demographic study is compiled from more than 130,000 interviews of skiers and riders nationwide. Helmet usage by skiers and boarders aged 18 to 24 is currently 32 percent – representing a 78 percent increase in usage for this age group since the 2002/03 season, when only 18 percent wore helmets. Ski helmet sales (adults and kids) have increased 43 percent over the past two years. Sales of adult ski helmets also increased 50 percent, according to the SnowSports Industries of America (SIA) annual Retail Audit.

### ***Directions to Gary and Helen Cheatham's lake property on Lake Ft. Gibson, Tulsa Lake Party location***

From Tulsa, take Hwy 51 east to Wagoner. In Wagoner go to the crossroads of Hwy 51 and Hwy 69 by Wal-Mart. Turn right. (South) Go south, about 1 mile, to S.W. 15th Street – it is the first traffic light. Turn left. Go about 1 mile. At the stop sign turn left. Go over the railroad tracks and turn right. This puts you on the outside of Wagoner.

Go 5 miles. You'll see a boat storage, Cobb's Equipment, and Morgan's Corner. You'll also see a sign for Long Bay Marina. Use the left hand turn lane. Turn left onto County Road 330. (This is the first left turn lane you'll come to.) Go to second stop sign and turn left on Long Bay Road. Turn right on Anchorage Road. (Second right.)

Look for Rainbow Lane sign and turn Left. Go about a block. Turn right through the gates and follow the road to the Picnic Shelter. Watch for Tulsa Ski Club (TSC) signs along the way so you know you are on the right track. They will be pink with black lettering. If you get lost, call for help. We want to party with you!!
